This retainer is non-refundable upon cancellation of the event, but may be re-applied (subject to availability) if the event is rescheduled. The fee for engagement session (if applicable) is due at the time of service. The remaining payment will be paid by client two weeks prior to the wedding date.

Limitation of liability:

While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding event, V.I. Photography & Design entire liability to client for any claim or loss will be limited to a full refund of the amount paid. In the unlikely event of personal illness or other circumstances beyond the control of V.I. Photography & Design, a substitute photographer of high qualifications may be substituted. Should the client decline this service, they may elect to terminate this agreement and receive a full refund. It is understood that no other photographer, amateur or professional, shall be allowed to photograph at the wedding while photographer Vincent Ivcevic is working. Any breach of this agreement will constitute a reason for non-completion of the job with no liability to V.I. Photography & Design

Federal Copyright Laws:

Any reproduction, sale or exhibition of any images photographed by Vincent Ivcevic is prohibited without specific consent of said photographer.

Model Release:

It is understood that all digital files remain the property of V.I. Photography & Design and that they may be used for professional competition, advertising, displays or any purpose thought proper by photographer Vincent Ivcevic without compensation to the client.

Completion Schedule: The printing process can only start once V.I. Photography & Design receives the order list for the required images. Digital processing takes approximately 2 weeks. Creation of a wedding album takes 8-12 weeks, enlargements 1-2 weeks or possibly longer when laboratory and bindery schedules are heavy.

All albums and prints included in the wedding package must be ordered within 12 months form the date of the wedding. After 12 months all unfilled orders will be forfeited.

CANCELLATION & POSTPONEMENT

The contract price is guaranteed only up to 30 days after the customer receives their preview images. Preview images must be picked up within 30 days of notification. In the event of a postponement or cancellation of this event with V.I. Photography & Design, the Studio must be notified in writing by U.S. Post by return signature, prior to the reserved date. Any retainer is retained by the Studio and will be forfeited if client postpones or cancels their event date. Cancellation does not negate the total balance due. Any balance prepaid to V.I. Photography & Design will be forfeited if client cancels fewer than 60 days prior to their event date. Furthermore, the total balance shall be due in if client cancels their event date fewer than 60 days prior to their event date. No partial orders will leave the Studio until the total balance is paid in full.
